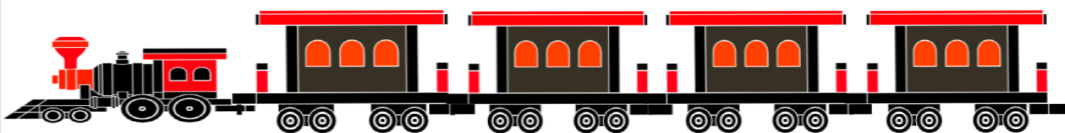

Effective October 1, 2021, The Retirement Office will no longer distribute Retiree check advices and newsletters via the U.S. Postal Service. Retirees can use the Web Member Services website to view their deposit advices, tax withholding elections, 1099-R direct deposit information and payment history. In order for a retiree to cover his/her dependents through Shelby County Government's health insurance plan, the retiree must remain covered under the plan. Shelby County Government offers health coverage to eligible retirees and their dependents, not to dependents only. This does not affect spousal benefits for retirees who currently have health coverage.

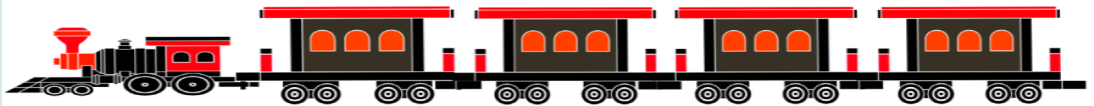
SPOUSAL CARVE OUT(Applicable to retirees enrolled in Shelby County Government's Health Care Plan)

If an employee's spouse is eligible for health coverage under his/her employer sponsored plan, the spouse is NOT eligible for coverage under the County's medical plan. Annually, employee/retiree will attest to whether his/her spouse is eligible for health coverage when enrolling in benefits.

It is a requirement, if eligible, that any retiree or dependent who is currently disabled, or becomes disabled, must also apply for Medicare Part A & B.

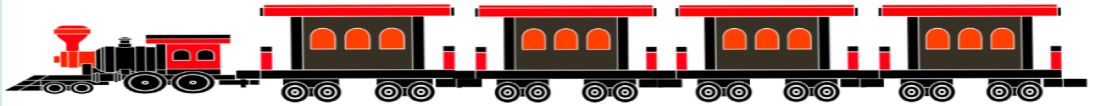
