Cost of Living Adjustment

We are pleased to announce the following cost of living adjustment (COLA) for certain retirees. The cost of living increase is included on your January 31, 2022 pension deposit. Increases are as follows:

Plan A and C Members will receive a 4% COLA

- Retirees age 65 or older as of 12/31/2021
- **Disabled Retiree**
- Dependent Children
- Spouse age 65 or older or receiving temporary 2 years benefit

Plan B Members will receive a 1% COLA

- Retirees & Spouses age 65 or older as of 12/31/2021. The original Retiree must have 25 years of service to qualify for this COLA.
- Disabled Children
- Retired before 1/1/2013
- Pension less than \$3000.00 per month

Plan D Members will receive a 2% COLA

- Retirees & Spouses age 67 or older as of 12/31/2021
- Dependent Children
- **Surviving Spouse**



Ingredients

- 4 cups boiling water
- 2 cups dried porcini mushrooms (about 1 1/2 ounces)
- 1 tablespoon cornstarch
- 1 tablespoon lower-sodium soy sauce
- % teaspoon kosher salt
- $\frac{1}{2}$ teaspoon black pepper
- 2 tablespoons olive oil
- 2 cups sliced shallots (about 8 ounces)
- 1 garlic clove, minced (about 1 teaspoon)
- 1 cup dry sherry
- 3 pounds assorted fresh mushrooms (such as cremini,
- portobello, shiitake, and button), sliced
- 1 ½ tablespoons chopped fresh thyme
- 1/3 cup heavy cream



It is essential that each retiree review his/ her deposit advice and report any discrepancies regarding his/her insurance deductions.




