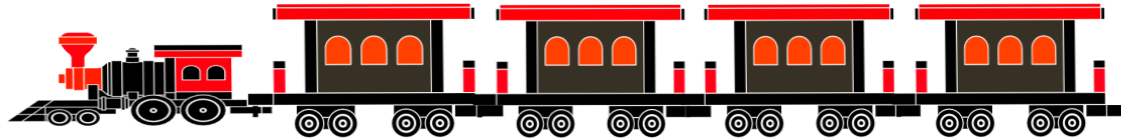

NOTIFICATION OF CHANGE

In order to improve overall office management and efficiency, effective **April 1, 2023**, Shelby County Retirement Office will no longer issue monthly payroll direct deposit advices. Your last direct deposit advice will be issued on **March 31, 2023**.

Monthly direct deposit advices and the Retiree Newsletter will be available on the Web Member Services site – <https://memberservices.shelbycountyttn.gov> and may also be accessed with your mobile device. In addition, retirees may contact their financial institution regarding the net amount of their monthly pension benefit.

Cost of Living Adjustment

We are pleased to announce the following cost of living adjustment (COLA) for certain retirees. The cost of living increase is included on your **January 31, 2023** pension deposit. Increases are as follows:

Plan A and C Members will receive a 4% COLA

- ❖ Retirees age 65 or older as of 12/31/2022
- ❖ Disabled Retiree
- ❖ Dependent Children
- ❖ Spouses age 65 or older or receiving 2-year temporary benefit

Plan B Members will receive a 1% COLA

- ❖ Retirees & Spouses age 65 or older as of 12/31/2022. The original Retiree must have 25 years of service to qualify for this COLA.
- ❖ Disabled Children
- ❖ Retired before 1/1/2018
- ❖ Pension less than \$3000.00 per month

Plan D Members will receive a 2% COLA

- ❖ Retirees & Spouses age 67 or older as of 12/31/2022
- ❖ Dependent Children
- ❖ Surviving Spouse

2023 FEDERAL TAX WITHHOLDING CHANGES

The IRS released a revised Form W-4P (Withholding Certificate for Periodic Pension or Annuity Payments) that includes substantial changes to the federal tax withholding elections.

These changes are effective January 1, 2023.

Shelby County retirees and beneficiaries who already receive ongoing payments and who do not wish to make changes to their federal tax withholding elections are not required to file a new form.

Our system has been updated to convert your 2022 withholding elections to the new 2023 calculation method. However, if you wish to make changes to your withholding status, on or after January 1, 2023, you will be required to use the new 2023 W-4P form. To obtain the new 2023 W-4P form, visit www.irs.gov or you may contact our office.

PLEASE BE ADVISED: Shelby County Retirement System staff members are not tax advisors and cannot advise or assist you with completion of the new 2023 W-4P form. For assistance, please contact your tax professional or the IRS for guidance.
