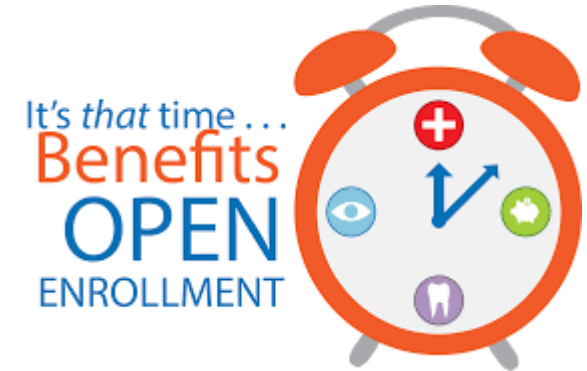
ALL POST-65 RETIREES COVERED ON AETNA MEDICARE ADVANTAGE STANDARD OR PREMIUM PLANS
