Cost of Living Adjustment

We are pleased to announce the following cost of living adjustment (COLA) for certain retirees and beneficiaries who are receiving a monthly benefit. The cost of living increase will be included on your January 31, 2025 pension deposit. Increases are as follows:

Plan A and C Members will receive a 2.4% COLA

- Retirees age 65 or older as of 12/31/2024
- Disabled Retiree
- Dependent Children
- Surviving Spouses age 65 or older or receiving 2-year temporary benefit

Plan B Members will receive a 1% COLA

- ❖ Retirees & Surviving Spouses age 65 or older as of 12/31/2024. The original Retiree must have 25 years of service to qualify for this COLA.
- Disabled Children
- Retired before 1/1/2018
- ❖ Pension less than \$3000.00 per month

Plan D Members will receive a 2% COLA

- ❖ Retirees & Surviving Spouses age 67 or older as of 12/31/2024
- ❖ Dependent Children
