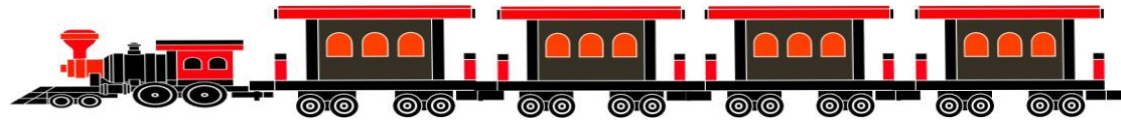

Cost of Living Adjustment

We are pleased to announce the following cost of living adjustment (COLA) **for certain retirees and beneficiaries who are receiving a monthly benefit.**

The cost of living increase will be included on your **January 31, 2025** pension deposit. Increases are as follows:

Plan A and C Members will receive a 2.4% COLA

- ❖ Retirees age 65 or older as of 12/31/2024
- ❖ Disabled Retiree
- ❖ Dependent Children
- ❖ Surviving Spouses age 65 or older or receiving 2-year temporary benefit

Plan B Members will receive a 1% COLA

- ❖ Retirees & Surviving Spouses age 65 or older as of 12/31/2024. The original Retiree must have 25 years of service to qualify for this COLA.
- ❖ Disabled Children
- ❖ Retired before 1/1/2018
- ❖ Pension less than \$3000.00 per month

Plan D Members will receive a 2% COLA

- ❖ Retirees & Surviving Spouses age 67 or older as of 12/31/2024
- ❖ Dependent Children

Please review your deposit advice on Web member Services and report any discrepancies regarding your insurance deductions.

Discrepancies must be reported within 60 days of each pay date in order to receive a credit for any incorrect changes.

As a participant in Shelby County Government's health insurance plan, it is a requirement that retirees and their dependent(s) obtain Medicare Part A & Part B approximately 3 months prior to turning 65. It is a requirement, if eligible, that any retiree or dependent who is currently disabled, or becomes disabled, must also apply for Medicare Part A & Part B. Please contact your local Social Security Office for further information regarding Medicare.
