Shelby County Government is committed to providing you with the tools and resources you need to make informed benefit choices. Before you enroll, carefully review this guide.

Online: Log in to <u>www.ShelbyCountyBenefits.com</u> to review your current benefit options and enroll for the 2022 plan year. You'll need to enter your last name, date of birth, zip code, and last four digits of your Social Security number. By Phone: Call 1-877-970-4320. Licensed Benefit Counselors are available Monday through Friday, from 7:30 a.m. to 7:00 p.m. Central time to answer your questions and help you enroll.

Qualifying Life Events

During the plan year, you can change your benefit coverage if you, your spouse, or your eligible dependents experience a Qualifying Life Event. Keep in mind, if you experience a Qualifying Life Event, you have 30 days from the date of the event to make changes to your benefits. You must contact Winston Benefits at **1-877-970-4320**, Monday through Friday, from 7:30 a.m. to 7 p.m. CST. If you do not change your benefits during the 30-day window, you will have to wait until the next Open Enrollment to change your benefit elections.

Qualifying Life Events include:

- Marriage
- Divorce
- Birth of a child or adoption
- Death
- A change in your spouse's employment status
- Loss of other medical coverage

Important Benefit Information

- ✓ Premium Deductions: All 2022 Open Enrollment changes are effective January 1, 2022 and remain in effect until the end of the plan year, December 31, 2022. The first premium change, should you change plans, will be reflected on your pension benefit payment in January 2022. Please refer to the premiums for benefit programs you are enrolling in to determine your correct deductions. You must notify the Retirement Office immediately, but no later than 30 days after your January 2022 pension payment benefit, if there are discrepancies.

Dental

Cigna Dental Prepaid/DHMO

The Cigna Dental Prepaid/DHMO plan provides dental services at predetermined copayment amounts, which are reduced fees for dental treatments when members receive service from their selected participating general dentist or from a participating specialist. **The premiums are lower for the Prepaid/DHMO Plan. The Plan Design and Patient Charge Schedule (PCS) are located on the Winston Benefits Online Portal.**

There are no deductibles to meet, no claims to file, no waiting periods for covered members, no annual dollar maximum, and preexisting conditions are covered.

You must designate a general dentist.

Cigna Dental DPPO Plan

The Cigna Dental DPPO plan offers flexibility in that you may choose any dentist; however, you receive maximum benefits when visiting a participating network provider.

No referrals are required, and you or your dentist will file claims for services rendered. **The annual maximum is \$2,000 per enrolled member. The Plan Design and Providers are located on the Winston Benefits Online Portal.**

Vision

Davis Vision

Davis Vision provides quality vision care and helps you save money on eye exams, eye glasses, and contact lenses. This is a comprehensive benefit that ensures low out-of-pocket cost to members and their families. You can choose to purchase eyeglasses or contacts every January 1 (Option 1) or every other January 1 (Option 2). **The Plan Design and Providers are located on the Winston Benefits Online Portal.**

FINANCIAL PROTECTION

Basic Life

Basic Life is offered by MetLife to retirees only. Coverage amounts are one times the annual salary at the time of retirement rounded to the nearest thousand.

Dependent Life

This is a closed benefit. Retirees cannot increase coverage nor can a retiree enroll. Retirees may drop coverage.

Accidental Death and Dismemberment (AD&D)

This is a closed benefit. Retirees cannot enroll nor increase or decrease existing coverage. Retirees may drop coverage.

Whole Life Insurance

Employees retiring on or after October 1, 2021 should contact Transamerica to continue Whole Life coverage.

Aflac (Cancer and Intensive Care Insurance)

Existing Aflac participants may keep their current Aflac individual plans; however, no new enrollments will be allowed. Should you need to make a change in your Aflac benefits, please contact Dianne Bradley at 1-**901-761-8002**.

Colonial Life Insurance

This is a closed benefit. Retirees must contact Colonial Life Insurance Customer Service at **1-800-325-4368** concerning their plan coverage, premium changes, and any other questions. Retirees cannot increase coverage nor can a retiree enroll.
