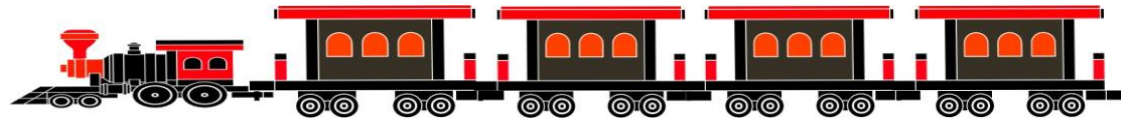

## ALL PRE-65 RETIREES ENROLLED IN COUNTY HEALTHCARE COVERAGE...

Shelby County has partnered with Buck, our benefits consultant, to conduct a Dependent Audit. This audit will determine continuation of dependent healthcare coverage.

**Previously submitted documents will not be considered.**

Verification of dependent eligibility plays an important role in helping the County maintain accurate records. Compliance reduces risks and costs.

Communications regarding this Dependent Audit will be sent via U.S. mail (address on file) and email. The U.S. mail notification will be packaged in a yellow envelope with red text.

- **On or around April 9, 2024:** Heads-Up Email and Letter, providing additional details about the Dependent Audit
- **On or around April 15, 2024:** Initial Notice Email and Information Packet, includes detailed instructions and guidance for completing the Dependent Audit
- **April 22, 2024:** Dependent Audit website goes live, [ShelbyCountyAudit.buckglobal.com](http://ShelbyCountyAudit.buckglobal.com)
- **May 27, 2024:** Deadline for completing the Dependent Audit

**IMPORTANT: Dependent coverage will be cancelled due to untimely submission of documentation.**

**Beginning April 22, 2024,** Eligibility Specialists will be available **Monday through Friday, (7 am and 5 pm CT)** at **1-855-610-3028**. Please do not contact the Retirement Office, Shelby County Human Resources (Benefits) or the Winston Benefits Center.

We appreciate your cooperation and timely response.

Please review your deposit advice on Web member Services and report any discrepancies regarding your insurance deductions.

Discrepancies must be reported within 60 days of each pay date in order to receive credit for any incorrect changes.

It is a requirement, if eligible, that any retiree or dependent who is currently disabled, or becomes disabled, must also apply for Medicare Part A & Part B.
